The complete package will include: use of entire 8 acre site from 10:00 am to 2 am., 100 year old farm house w/A/C for bridal party, solid post & beam tent like dining hall with 1400 sq. ft wooden dance floor, rehearsal, head table risers, podium, P/A system, outside ceremony with chair placement & P/A system, 10+ ceremony locations, 2500 sq. ft. patio with fireplace stocked all evening, *ask about reduced prices for May and October weddings.
